### **Qualification Details**

#### The Qualification

The TQUK Level 3 Award in First Aid at Work (RQF) is regulated by Ofqual.

#### **Qualification Purpose**

The purpose of the qualification is for the learner to attain knowledge and practical competences required to deal with a range of workplace first aid situations.


The TQUK Level 3 Award in First Aid at Work (RQF) is aimed at learners already working or preparing to work in industry. The qualifications is usually delivered as a three-day programme of training and assessment for learners to allow them to be the first aiders in the workplace.

The qualification develops learners knowledge, understanding and skills in the following areas:

- Roles and responsibilities of the First Aider;
- Assessing an incident;
- Recognising signs and symptoms of injury and illness;
- Assisting a casualty who is suffering from major injury and illness;
- Chest injuries;
- Spinal injuries;
- Anaphylaxis.

The objectives of the qualification include supporting a role in the workplace and giving learners personal growth and engagement in learning.

If this qualification is being used to meet the requirements of the HSE then it is valid for 3 years, after which learners will need to repeat the qualification, however it is recommended that learners refresh their knowledge annually.

#### **Entry Requirements**

There are no specific entry requirements however learners should have a minimum of level 2 in literacy and numeracy or equivalent.

The recommended minimum age for this qualification is 14 years and above.

#### **Progression**

Successful learners can progress to other qualifications such as:

- Level 3 Award in Paediatric First Aid.
- Level 2 Award in Cardio Pulmonary Resuscitation and Automated External Defibrillation.

#### **Directed Study**

Learners are expected to study and complete aspects of their assessment portfolio in their own time.

**Expected Directed Study Time for this qualification:** 4 hours.

#### **Total Qualification Time**

This is an estimate of the total length of time it is expected that a learner will typically take to achieve and demonstrate the level of attainment necessary for the award of the qualification i.e. to achieve all learning outcomes.

Total Qualification Time is comprised of GLH and an estimate of the number of hours a learner is likely to spend in preparation, study or any other learning, including assessment, which takes place as directed by, but not under their supervision of a lecturer, supervisor or tutor. The credit value, where given, for a qualification is determined by TQT. One credit corresponds to 10 hours of learning.

Total Qualification Time for this qualification: 22 hours.

#### **Grading & Assessment**

The units will be delivered, assessed and quality assured in accordance with the Assessment Principles for Regulated First Aid Qualifications.

The qualification is assessed by internally set and marked assessments, subject to external quality assurance.

The assessment methods for this qualification are:

- Practical demonstration and assessor observation.
- Written questions.

The practical assessment of learners for the qualification will be embedded into the course delivery.

The written assessment will be done without access to the course manual.

Learners will be required to demonstrate their knowledge and understanding by answering a range of questions relating to the assessment criteria.

All assessment materials have been checked approved by TQUK.

All learning outcomes must be met to achieve a PASS. There is no grading.

#### Centre Recognition

In order to offer TQUK qualifications, Stiering Lives must be recognised by TQUK, and meet the qualification criteria.

#### **Learner Registration**

In order to receive their certificate, learners are usually registered with TQUK before the course commences. However, learners can be confirmed after the course, in the case of any substitutions being made at short notice.

#### **Quality Assurance Requirements**

#### Trainer / Assessor

In order to teach and assess TQUK courses, Stiering Lives trainers must posses teaching and assessment qualifications appropriate for the level of qualification they are delivering. For example, as a minimum:

Teaching: Level 3 Award in Education & Training

• Assessment: Level 3 Certificate in Assessing Vocational Achievement

Trainers must also be occupationally competent, and qualified in their field, at least to the same level or above that which they are teaching.

Trainers must also show evidence of continuing professional development on an annual basis.

This course will require 1 trainer for every 12 students.

#### **Internal Quality Assurer**

In addition, a sample of the assessor's work will always be Internal Quality Assured by a different staff member to maintain quality. Internal Quality Assurers (IQAs) must hold, or be working towards, an appropriate IQA qualification. For example, as a minimum:

• IQA: Level 4 Award in the Internal Quality Assurance of Assessment Processes & Practice.

Appropriately qualified staff members can fulfil the role of both Assessor or IQA on different courses, but an Assessor cannot IQA their own work.

#### **External Quality Assurer**

At least once a year, External Quality Assurers (EQAs) from TQUK will check a sample of student's work from courses delivered over the previous 12 months, to further quality assure our assessment and IQA practices.
